CONDITIONS OF ENTRY

- 1 Entry fee is \$10 for members \$20 Non members
- 2 All artwork must be original and sole work of artist.
- 3 Sculptures must have plinth provided and jewellery in a lockable glass case.
- 4 Open to all mediums (Excluded are photography, giclee and computer art).
- 5 For couriered work a **RETURN COURIER TICKET** must be included with your work. Please provide packaging adequate for safe return.
- 6 Work must have Artists Name, Title, Medium and price via a swing tag attached to the rear of the work.
- 7 **Paintings must be suitably mounted ready for hanging and not have protruding screws.**
- 8 A high standard of presentation is required. **Wet work or non-compliance of conditions may mean work is not displayed.**
- 9 Artwork size – no restriction
- 10 Commission of 25% per item sold. All work must be FOR SALE
- 11 Exhibitors may enter up to **3 works for main exhibition** and **1 work for separate category “REVIVAL”.**
- 12 Work may NOT have been exhibited before IN A COAS EXHIBITION.
- 13 Work that has had an award in a previous exhibition will not be eligible for an award.
- 14 Insurance of work is THE sole responsibility of entrant.
- 15 NEW - See separate form for unframed Folder items.
- 16 The judge's decision is final and no discussion will be entered into.
