### **CONDITIONS OF ENTRY**

- Open to any artist who resides in Central Otago (including Wanaka and Queenstown Lakes District) and any Central Otago Art Society member.
- Entry limited to one piece per artist, not previously exhibited publicly in the South Island.
- All works must be original, the sole work of the artist, completed within the last two years and are subject to selection.
- · Please only one-off original works of art.
- The Awards are not open to digitally enhanced images, photographic images or prints in any medium.
- Works must be totally dry, professionally presented, ready for hanging with D-rings and have no protruding screws.
- Sculptures must have a plinth provided and jewellery must be in a lockable case.
- The longest side of the artwork must not exceed 1200mm (including frame). This size limit will be strictly adhered to.
- Artist's name as for catalogue, title of work, medium and price must be on back of work, as well as on a swing label.
- The organisers reserve the right to photograph or reproduce illustrations of selected artworks, for publicity relating to the exhibition.
- All artworks must be for sale. A 30% commission will be deducted on all sales
- Works not collected by 11am Monday 12 November from the Lake Dunstan Boat Club can be collected from Community House, Alexandra.
